Program Description

Integative Human Biology (IHB) is a field that integrates the biological and behavioral sciences as they apply to *Homo sapiens*. The IHB minor consists of courses in human form and function, human evolution and biological variation, human behavior, and the roles humans play in local and global ecosystems. The aim is to provide students with the background they will need as professionals in the 21st Century health sciences and many other fields that engage directly with aspects of human adaptation and welfare. The interdisciplinary IHB minor was approved by the Regents July 17, 2009 and began enrolling minors during the 2009-2010 academic year.

Enrollment and Revenue Data

This interdepartmental minor program is comprised of existing courses in biology and anthropology. Consequently, it is not possible to estimate proportion of students in courses generated by IHB minor students, since some would likely have taken the courses in any case as a part related major requirements. Similarly, since the curriculum consists of existing disciplinary based courses, faculty FTE and revenue attributable to IHB minor students is not available. Institutional Analysis of Program to Date

We view the IHB minor program as a success; a minor that fills a need and the desires of a student constituency. This is based on the growing number of minor graduates over the last two years, as well as the increased number of declared minors over the very short period of its existence. The faculty advisory committee for the minor (two biology faculty and two anthropology faculty) meets regularly and monitors the effectiveness of the course requirements and makes changes to the curriculum when deemed necessary to respond to student needs. We also coordinate with the collaborating departments with respect to frequency of course offerings to assure that IHB minors will be able to take required courses in a timely manner. Since all courses in the minor are currently existing courses in one of the two collaborating departments, no issues of staffing or funding are relevant. The courses enroll not only IHB minors but other students, as well.

Employment Information

The program is sufficiently new, and the number of graduates over only two years sufficiently small, that placement data for students opting to take this minor are not currently available.
